

2009-2010 Term TUITION FEE SCHEDULE

Montessori School House is dedicated to the philosophy of Dr. Maria Montessori. Offering Programs based on 3-Year Developmental Cycles: Primary for 3 thru 5 years, Transitional 6 year olds and Lower Elementary 7 thru 9 years. Future plans for a Toddler program and in the year of 2012 expansion including Upper Elementary.

School Term is based on a 9 month commitment, September thru May or completion of term with mid term enrollment. All tuition is required in pre-payment. Term payments received before July 15, 2009 will have a 10% discount. Monthly payments are contracted with credit approval and an additional \$50.00 fee. Non-contracted monthly tuition may be accepted with a 10% monthly increase of posted tuition schedule.

MSH opens at 7:30 am, children may arrive between 7:30 and 8:25 am. Classes begin promptly at 8:30 am.

CONTINUOUS ENROLLMENT AGREEMENT

1. The Parent agrees to pay the tuition and all fees for the Program Request and level in which his or her child is to be enrolled in accordance with the Tuition Fee Schedule.
2. Upon the signing of this Agreement the parent agrees to Continuous Enrollment for the entire 9 month 2009-2010 Term, or completion with mid-term enrollment.
3. The Parent agrees that accepting placement at another school, (public or private) before completing the 2009-2010 Term DOES NOT void this agreement.
4. The Parent agrees that MSH shall have the right to refuse to admit the child to class if this agreement is unsigned.
5. The Parent agrees that if payment of tuition and fees are not made in accordance with this Agreement, MSH shall have the right to withhold the transcript of the child's academic records until all tuition and fees have been paid.
6. The Agreement assumes that whenever a student is enrolled, it is with the intent to continue the Full Primary OR Elementary Program. The Parent further agrees that the withdrawal or dismissal of the child after the execution of this Agreement, whether as a result of accident, transfer, sickness, disciplinary action, or otherwise does not Warrant refunds of any kind.
